Further Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that **Dr. Rekha Jain**, has been appointed as **Independent Woman Director** and **Shri Balwant Singh**, **IAS** (**Retd.**) as **Independent Director** on the Board of Directors of Gujarat Gas Limited w.e.f. 20<sup>th</sup> April, 2022 for a tenure of 5 years, subject to approval of Shareholders. They are not related to any Directors of the Company.

It is also informed that Dr. Rekha Jain, Independent Woman Director and Shri Balwant Singh, IAS (Retd.), Independent Director are not debarred from holding the office of director by virtue of any SEBI order or any other such authority.
