Through this initiative, both companies aim to cater to the evolving needs of consumers by providing a diversified range of energy solutions readily accessible through GGL's extensive network of outlets.
- Supply of Automotive Lubricants: BPCL will supply automotive lubricants, greases, and specialties for sale at both GGL's COCO (Company Owned Company Operated) and franchise outlets. This joint endeavour underscores the commitment of both companies to enhance customer experience by offering high-quality products and services at various touchpoints.

Expansion of CNG Infrastructure:

- Setting up of CNG Facility at BPCL COCO Outlets: BPCL agrees to explore the possibility of setting up CNG facilities at its COCO outlets in line with GGL's Full Dealer Owned Dealer Operated scheme (FDODO scheme).
- 2. Setting up of CNG Mother Facility at BPCL Outlets: BPCL agrees to offer its outlets for setting up of Mother Facility for CNG Dispensing.

This initiative aims to bolster the infrastructure for clean energy solutions in Gujarat, aligning with the companies' shared vision of promoting sustainable energy alternatives and reducing carbon emissions.

The MOU, which comes into effect immediately, reflects the commitment of both companies to mutual cooperation and innovation in the energy landscape. As they embark on this collaborative journey, GGL and BPCL reaffirm their dedication to delivering sustainable, reliable, and customer-centric solutions to communities across Gujarat.
